Subject: NCI Bid Board Posting – Bulk Liquid Nitrogen (LN2) Building 41

Liquid Nitrogen, LN2, is necessary to deeply freeze valuable research cell lines. A constant supply of LN2 is crucial for maintaining temperature in specialized freezers. It is supplied to the National Cancer Institute, Center for Cancer Research, in Building 41 from the bulk tank near the loading dock.

The National Cancer Institute plans to purchase the bulk LN2 from Roberts Oxygen, Gaithersburg, MD. This is not a request for a competitive quotation. However, if any interested party believes it can meet the attached requirements, it may submit a statement of capabilities. The capability statement must be in writing and must contain information and material in sufficient detail to allow NCI to determine if the party can fully meet this requirement. The capability statement must be received in the contracting office by 11:30 AM on January 23, 2025 ET. A determination by the Government not to compete with this requirement based upon responses to this notice is solely within its discretion. Information received will be considered exclusively to determine whether to conduct a competitive procurement.

Sole Source Justification:

Roberts Oxygen Company is the only company that can provide NCI/CCR bulk liquid nitrogen gas with a daily delivery schedule at the NIH campus and is available if an emergency occurs. Their skilled technicians are also readily available if an emergency repair or adjustment is required, ensuring uninterrupted supply and service.

Statement of work for Roberts Oxygen for delivery of Liquid Nitrogen to Building 41 Bulk Tank:

<u>SCOPE</u>: Roberts Oxygen shall provide all labor, material, and supplies for delivery of Liquid Nitrogen, LN2, to the Bulk tank outside of Building 41. This gas is essential to support research in NCI/CCR. All work shall be performed in accordance with the manufacturer's standard commercial maintenance practices.

Upon delivery of gas if any part of the equipment is not functioning properly the Contractor shall furnish a qualified, factory-trained service representative to inspect the equipment and identify all repairs and adjustments necessary to restore the equipment to normal and efficient operating condition.

<u>REPLACEMENT PARTS</u>: The contractor shall furnish all required replacement parts at no additional cost to the Government. Parts shall be new or remanufactured to original equipment specifications. The contractor shall not be responsible for any repairs necessitated by abuse, neglect, vandalism, Acts of God, fire or water. These repairs shall be the subject of a separate purchase order and shall not be performed under this contract.

(d) *Inspection/Acceptance*. The Contractor shall tender for acceptance only those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. The Government must exercise its post acceptance rights-

(1) Within a reasonable period of time after the defect was discovered or should have been discovered; and

(2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(e) *Excusable delays*. The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence, such as acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(f) *Termination for the Government's convenience*. The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the

notice of termination, plus reasonable charges that the Contractor can demonstrate to the satisfaction of the Government, using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred that reasonably could have been avoided.

(g) *Termination for cause*. The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(h) *Warranty*. The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.
